## WHAT IS THE UROLIFT™ SYSTEM PHYSICIAN GATEWAY?

It is an easy-to-use portal for physicians who are or wish to participate in our programs - Physician Locator and/or Center of Excellence (COE) programs.

### Gateway benefits include:

- Current program status
- Downloadable approved IPSS tracker
- Patient IPSS data entry via direct entry or upload of approved IPSS tracker
- Clear displayed renewal date
- Automated notifications for renewal



## REGISTRATION

- You should only register for the Gateway if you meet the requirements to be added to the Physician Locator, or are already active in the Physician Locator or COE program.
- All first-time registrants for the Physician Locator must be approved. Please allow up to 5 business days. We will contact to you via email with your status.

## APPLYING TO THE PHYSICIAN LOCATOR/ VIEWING YOUR DASHBOARD

**New to Physician Locator? Already participating in Physician Locator and/or COE? Once registration is approved, you will be asked to enter additional information.**

- Once application is approved, you will be able to view your dashboard.

**If you are already participating in our programs, we will attempt to match you to our records.**

- If a match is found, you will be asked to enter additional information and then be taken to view your dashboard.
- If no matches are found, a member of the Gateway team will be notified and will reach out to you via email with next steps.

## INTERESTED IN BECOMING A COE?

Once your account is active and you can view your dashboard, you can begin tracking for COE by entering the requested data.

## PHYSICIAN LOCATOR INFORMATION AND REQUIREMENTS

The Physician Locator was created to support patients who want to learn more about the UroLift™ System by helping connect them to UroLift™ System-trained physicians.

### To be listed on the UroLift.com Physician Locator, a physician must:

- Complete the UroLift™ Proficiency Pathway (UPP)<sup>1</sup> or equivalent training.<sup>2</sup>
- Complete at least 15 cases in the last 5-month period.

### A physician receiving UroLift™ training in Residency must:

- Complete the UroLift™ Residency Proficiency Pathway (RPP)<sup>3</sup> certification
- Complete at least 15 cases in the last 12-month period
  - Cases can be in residency or a mix of residency and in practice
  - Complete a Teleflex Clinical Affairs refresher training and proctored case in practice

**To remain on the Physician Locator, a physician must complete at least 10 cases in the 12 month review period with at least 5 completed in the last 6 months of the review period.**

The 12-month review period is based on the date the physician is added to the Physician Locator. A physician will be removed from the Physician Locator if they have not met the above requirements.

**To be added back to the Physician Locator, a physician must complete at least 5 cases in the last 6 months.**

**Please note:** Physicians who have achieved COE designation do not need to requalify separately for the Physician Locator each year and are listed on the Physician Locator as part of their COE qualification. Should a physician not renew their designation for the Center of Excellence program, they must meet the Physician Locator annual requirements to remain listed on UroLift.com.

## UROLIFT™ SYSTEM COE PROGRAM INFORMATION AND REQUIREMENTS

The UroLift™ System COE Program is designed to enhance patient outcomes and experience. Urologists included in the UroLift™ System COE Program have achieved a higher level of training with the UroLift™ System and demonstrated a commitment to care for men suffering from symptoms associated with Benign Prostatic Hyperplasia (BPH).



### To qualify for the UroLift™ COE designation, a physician must:

1. Complete the UroLift™ Proficiency Pathway (UPP)<sup>1</sup> or equivalent training,<sup>2</sup> at time of initial designation.
2. Participate in the 12 month period prior to submission for designation or re-designation<sup>4</sup> in a minimum of:
  - Two Teleflex Clinical and Medical Affairs-led educational events for initial designation.
  - One Teleflex Clinical and Medical Affairs-led education event per year for re-designation.
3. Complete a minimum of 60 UroLift™ System cases in the 12-month period prior to submission for designation or re-designation.<sup>5,6</sup>
4. Submit the following data on a minimum of:
  - 30 UroLift™ System cases completed in the 12-month period prior to submission for designation, or
  - 15 UroLift™ System cases for re-designation,<sup>5</sup> de-identified data evidencing:
    - Pre- and post-procedure International Prostate Symptom Scores (IPSS) demonstrating an average improvement in IPSS of 40% or greater compared to baseline average;
    - The dates of the UroLift treatment, pre- and post-procedure IPSS assessments; and
    - Use of BPH medication at the time of the pre- and post-procedure assessments.

If a physician does not renew their designation as a UroLift™ System COE physician, the physician will be notified, the physician's status as a COE will be suspended, and their COE insignia will be removed from the Physician Locator. That physician will be reviewed by Teleflex™ to determine whether they meet the requirements to remain on the Physician Locator. If the physician does not meet the Physician Locator requirements, the physician will be notified and removed from the Physician Locator entirely.<sup>7</sup>

1. UPP is a surgeon-training program that includes modular, didactic and hands-on device training and guided completion of 15 cases. For more information about UPP, contact your Teleflex representative. 2. Physicians who were trained prior to March 2017 received equivalent surgeon training to the requirements outlined above, including instructional didactic sessions, clinical video review and hands-on UroLift™ System use. The current and prior training programs focus on identifying appropriate patient candidates; preparation and operation of the UroLift™ System; and surgical technique. 3. RPP is a residency surgeon-training program that includes modular, didactic and hands-on device training and guided completion of 15 cases. For more information about RPP, contact your Teleflex representative. 4. In situations where elective procedures were impacted due to a national health crisis, the 15-month period for designation or re-designation may be addressed to provide accommodation. Therefore, the assessment period may not be consecutive months. 5. Excluding cases completed during UroLift™ Proficiency Pathway training. 6. Completion may include proctored cases in connection with a Teleflex Clinical and Medical Affairs-led peer-to-peer educational event. 7. Physicians that were removed from the Physician Locator prior to September 2018 need to meet the initial add requirements to be added back.
